District #4 - 4 year term - The RRSWCD Board of Supervisors are elected by the registered voters county wide. To file for this position, you must reside in Caledonia City, Caledonia Township, Eitzen City, Mayville Township or Winnebago Township

District #5 - 4 year term - The RRSWCD Board of Supervisors are elected by the registered voters county wide. To file for this position, you must reside in Houston City, Houston Township, Money Creek Township, Sheldon Township or Yucatan Township.
